SOME OF THE LANGUAGE APPEARS TO BE TROUBLESOME (8 HOURS/5 DAYS A WEEK) WE STILL NEED TO FIND OUT ABOUT MOST OF THE LANGUAGE. WE WILL REPORT BACK TO THE MEMBERSHIP AFTER THIS MEETING IN NEW YORK... YOU WILL BE KEPT INFORMED. IT IS NOT OUR RESPONSIBILITY TO SAFISFY THE USPS FINANCIAL DIFFICULTIES.....

VICE-PRESIDENTS REPORT; RAY REPORTS ON SEVERAL MORE PAY-OUTS FROM GRIEVANCES AND SAID THEIR SHOULD BE MORE JOBS PUT UP AT THE NEXT BIDDING CYCLE..RAY ALSO DISCUSSED THE CONTRACT AND DOES NOT LOOK UPON IT FAVORABLY BUT WE HAVE TO KNOW MORE ABOUT THE LANGUAGE. RAY WILL BE IN NEW YORK FOR THE MEETING. CLERK-CRAFT DIRECTOR; STEVE REPORTS THAT MANY WEEKEND JOBS WILL BE POSTED...STEVE ALSO DOESN'T LIKE WHAT HE HAS SEEN SO FAR ON THE NEW CONTRACT. IT LOOKS LIKE HARD TIMES AHEAD UNLESS MANAGEMENT CHANGES ITS STRIPES.....NOT LIKELY.... MVS REPORT; BOBBY REPORTS VOTE NO ON THE NEW CONTRACT, THEIR ARE TO MANY AREAS THAT MANAGEMENT CAN EXPLOIT AND WILL. MAINTENANCE REPORT; KEVIN FARNOLI GAVE THE REPORT. (CRAFT-DIRECTOR LLOYD BRAZEE) IS AT SCHOOL.....MANY JOBS HAD TO BE REPOSTED BECAUSE THE PR'S WERE SCREWED UP...VACATION SELECTIONS ARE NEARLY COMPLETE,,,, DIRECTOR OF ORGANIZATION; ANN REPORTS NO CHANGES IN THE MEMBERSHIP AND REMINDS PEOPLE OF OUR FAMOUS MAY BREAKFAST TO BE HELD ON SATURDAY, MAY 7TH....


