## PRESIDENTS REPORT/SUNDAY MAY 18<sup>TH</sup> 2008;

I HAVE BEEN NOTIFIED BY APWU HUMAN RELATIONS DIRECTOR SUE CARNEY THAT THE SOUTHEASTERN NEW ENGLAND DISTRICT RECEIVED VALIDATION FOR PHASE-2 OF THE NRP PROGRAM ON MARCH 28,2008.

LOCALS CAN BE EXPECTED TO BE CONTACTED BY LOCAL POSTAL MANAGEMENT WITHIN 4-6 WEEKS AFTER THE PHASE-1 VALIDATION. I HAVE YET TO BE NOTIFIED YET. SO, INSTEAD OF WAITING I SENT AN INFORMATION REQUEST ON MAY 9<sup>TH</sup>. I RECEIVED A RESPONSE YESTERDAY. AS EXPECTED IT WAS A TWO-PAGE LETTER BASICALLY STALLING MY REQUEST.

I RESPONDED WITH ANOTHER LETTER INFORMING MANAGEMENT THAT I WANT THIS INFORMATION WITHOUT FURTHER DELAY OR I WILL SEEK OTHER ALTERNATIVES. THESE LETTERS ARE POSTED ON THE BULLETIN BOARDS.

A QUARTERLY MEETING HAS BEEN SCHEDULED FOR MAY 28<sup>TH</sup>. THE TOPICS INCLUDE THE BID CYCLE. MMANAGEMENTS DISREGARD TO UNION REQUESTS TO SCHEDULE STEP-1 MEETINGS AND INFORMATION REQUESTS.

I HAVE ALSO BEEN INVITED TO ATTEND A MEETING ON JUNE 19<sup>TH</sup> WITH THE DISTRICT MANAGER, PLANT MANAGER AND ANN MAILOUX WHO IS THE MANAGER OF HUMAN RESOURCES AND MOST LIKELY IN CHARGE OF THE NRP PROGRAM. I LOOK FORWARD TO INTRODUCING MYSELF TO MS. MAILOUX

I RECENTLY SPENT TWO NIGHTS ON TOUR-1 AT THE PLANT ON CORLISS STREET TO SPEAK WITH THE MEMBERS I DON'T SEE VERY MUCH. AFTER TWO DAYS OF CONVERSING SOMETHING DID NOT SIT RIGHT. THEIR WERE BASICALLY THREE CONSTANT COMPLAINTS. ONE, WHERE IS MY OVERTIME, TWO, WHY DO I HAVE TO GO ON BREAK AT TWO INSTEAD OF THREE, AND THIRD, EMPLOYEES RATTING OUT OTHER EMPLOYEES.

OVER THE PAST FEW MONTHS MANAGEMENT HAS ATTACKED OUR PRIVATE MEDICAL RECORDS WHICH IS AN INVASION OF PRIVACY....ILLEGALLY CHANGING THE FMLA

LAWS AND COMPROMISING OUR WEINGARTEN RIGHTS. NOW THEY ARE GOING INTO PHASE-2 OF THE NRP PROGRAM.

SO IS THIS WHERE WE ARE AT??? WITH EVERYTHING BEING DONE TO US BY THE POSTAL SERVICE, THE NLRB AND OUR OWN CONSTITUENTS WHAT CONCERNS US MOST IF OVERTIME, BREAKS AND TELLING SUPERVISORS THAT SOMEONE ELSE IS NOT RUNNING THEIR MACHINE. THIS TROUBLES ME VERY DEEPLY. THE NEXT FEW YEARS WILL BE VERY DIFFICULT ONES FOR US TO SAY THE LEAST.

I REALIZE THAT MOST MEMBERS EXPECT THE UNION TO DO "EVERYTHING" AND NEVER PARTICIPATE. THIS EXPECTATION IS UNREALISTIC BECAUSE THE TASK IS TOO MUCH FOR ANYONE. AT SOME POINT THIS LOCAL NEEDS TO COME TOGETHER BECAUSE I CAN TRULLY SAY WE ARE ON OUR OWN. OUR REPRESENTATIVE IN THE HOUSE AND CONGRESS DON'T CARE, THE NLRB DOESN'T CARE, BUT I DO...THAT IS THE REASON I RAN FOR THIS JOB. WITHOUT MORE INVOLVEMENT FROM THE MEMBERS THIS TASK IS TOO GREAT.....

I LEAVE YOU WITH A LITTLE MANTRA....IF I CONTINUE TO DO WHAT I HAVE ALWAYS DONE, THEN I AM GOING TO GET WHAT I ALWAYS GOT.....

\$150. TO THE HARMONY LODGE CHARITY GOLF TOURNAMENT.



If you are one of the unassigned regulars due to conversion from PTF to regular you need to continue to bid. If you see a job that is close to days off and hours you want bid it. If you are unassigned at the end of this staffing review you will be placed in a residual yacancy. We still have about 8 new jobs that have to be created due to the conversion:

Two things to keep in mind when bidding; 1 if you are awarded a job that requires training <u>CONTACT TRAINING</u>. The phone numbers are as follows 276-6849,6848,5042,5040,6890. Do not wait to be contacted or receive a letter it will NOT happen. The way the bidding process/shared service has been contracted out it just doesn't happen the way it used to or should. Also when bidding and you are awarded a bid whether it requires training or not and have bid on another job during the same posting, send a letter to local shared services aka personnel to remain a live bidder if you are interested in another job in that cycle. Some jobs you shouldn't have to and the bidding process should drop down to the proper person BUT IT DOESN'T HAPPEN. So contact local services in writing wishing to remain a live bidder.
